Latitude and longitude were measured using the Trimble R8. The equipment used is GPS. There exists a 0.5' (five tenths) plus or minus precision. The real time networks used are FDOT and Topcon. Item listed in c2(e) is the air conditioning unit on the rear of the building. According to the 2017 FL building code, an elevation 1.0' higher than that shown in b9 must be used for construction purposes. Certain municipalities may have this elevation difference at an even higher number. Date of field work is 12/13/2023.
