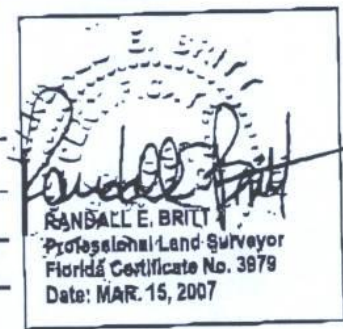

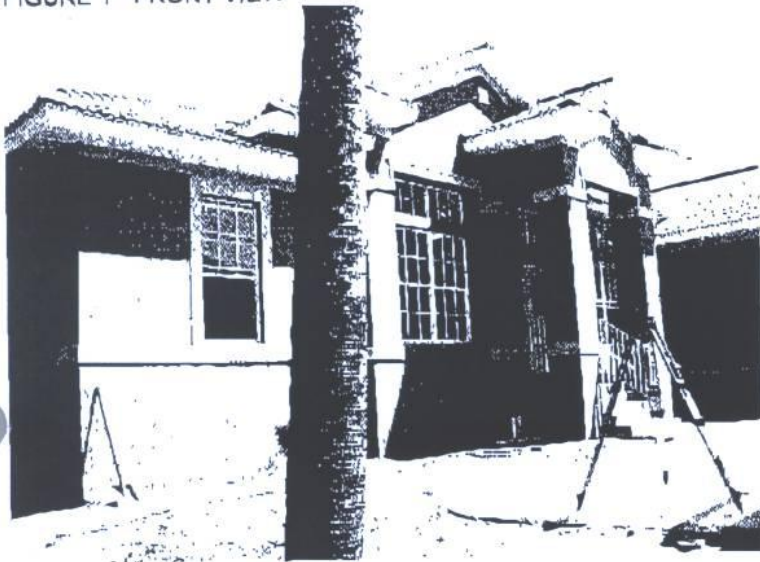
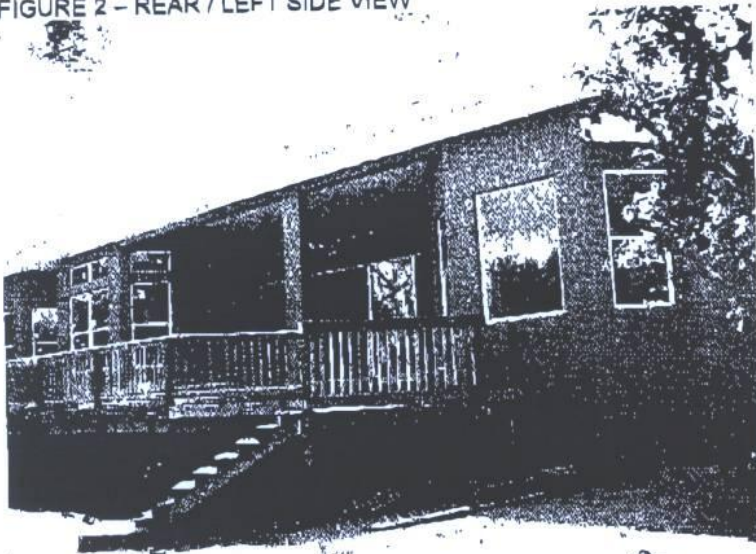


FIGURE 2 - REAR / LEFT SIDE VIEW

FIGURE 3 - REAR / RIGHT SIDE VIEW

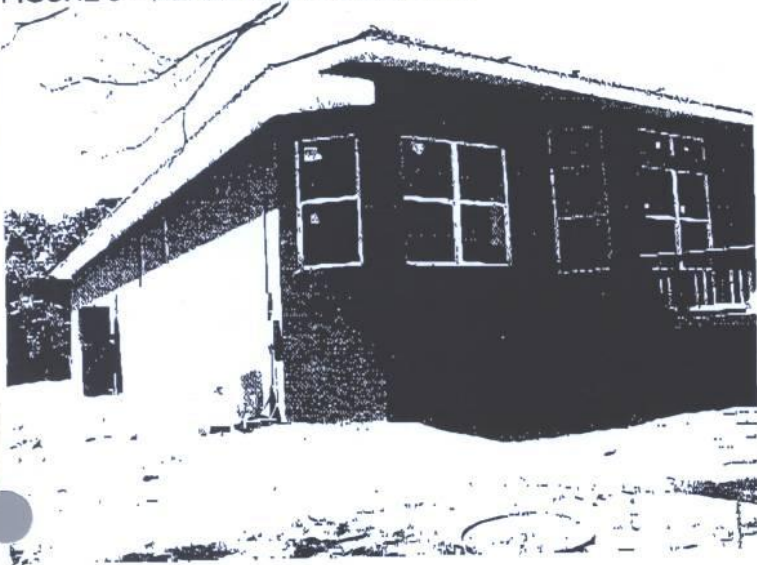


FIGURE 4 - GARAGE FLOW THRU
