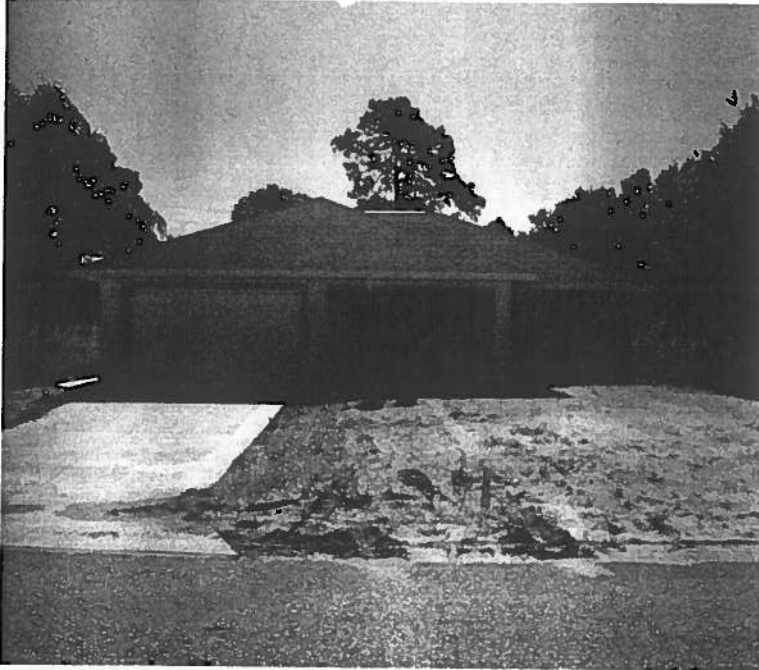


FIGURE 2 – JULY 5, 2006 - REAR VIEW
