SECTION E CERTIFICATION

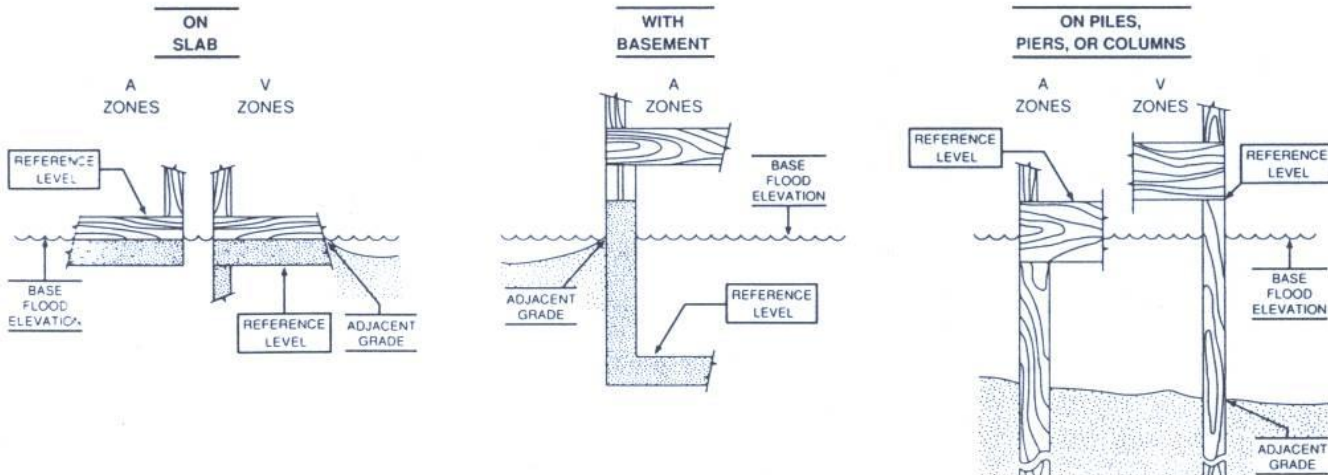
