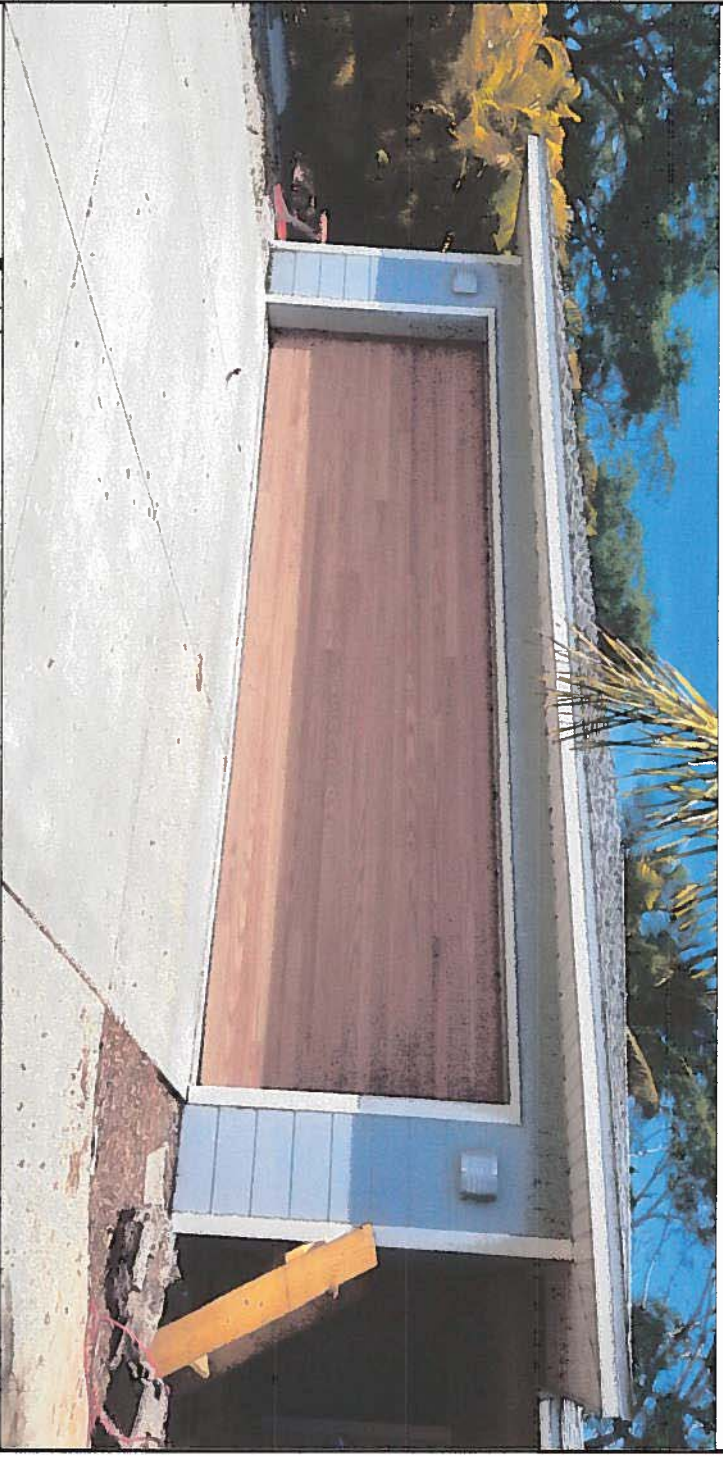


Photo One Caption Front view
