THE BENCHMARK UTILIZED FOR THIS CERTIFICATE IS A NATIONAL GEODETIC SURVEY BENCHMARK G 634 WITH AN ELEVATION OF 8.22 FEET NAVD 1988. THE ELEVATION WAS CONVERTED USING NATIONAL GEODETIC SURVEY ON LINE SOFTWARE (VERTCON). THE RESULTING ELEVATION = 9.329 FEET NGVD 1929. THE DATA SHOWN IN SECTION C2.a-h IS BASED ON NGVD 1929.

THE LOWEST MACHINERY SERVICING THE BUILDING IS THE A/C UNIT AS SHOWN IN LEFT SIDE VIEW- PHOTOGRAPH WITH AN ELEVATION OF 11.04 FEET.

HOMEOWNERS WERE NOT HOME AT TIME OF ELEVATION CERTIFICATE - NO ACCESS TO THE GARAGE; UNKNOWN LOCATION OF THE WATER HEATER, WASHER/DRYER AND AIR HANDELER.

THE LATITUDE AND LONGITUDE AS SHOWN IN SECTION A5 WAS OBTAINED USING A HAND HELD GPS DEVICE WITH AN ACCURACY OF 15 FEET  $\pm$ .
