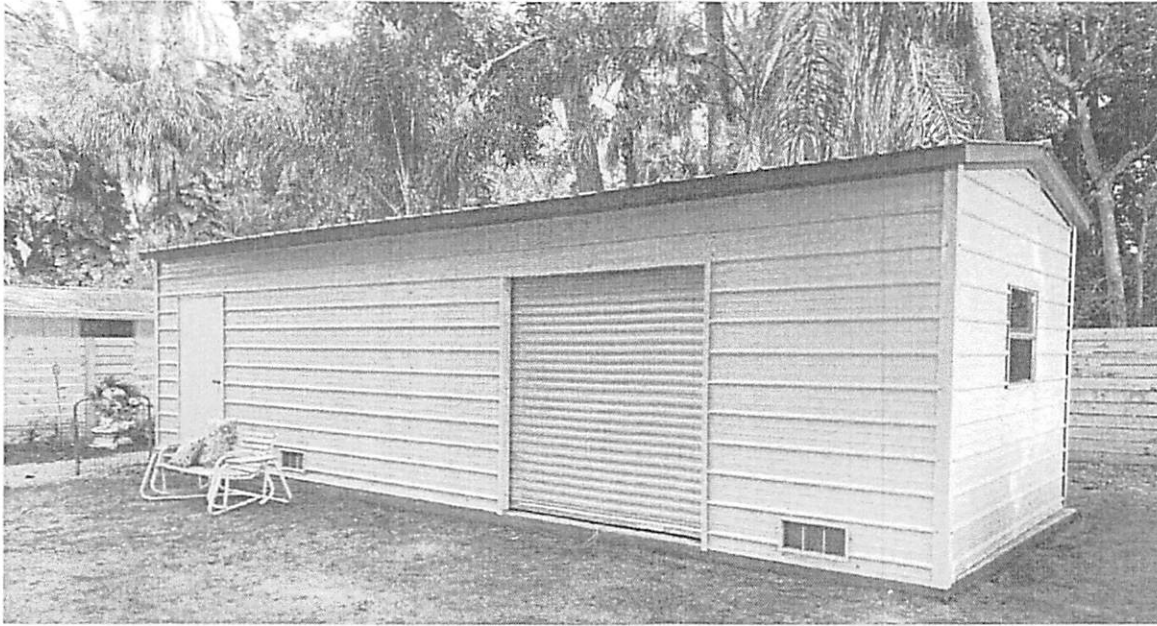

Photo One Caption FRONT VIEW – 03/29/2021

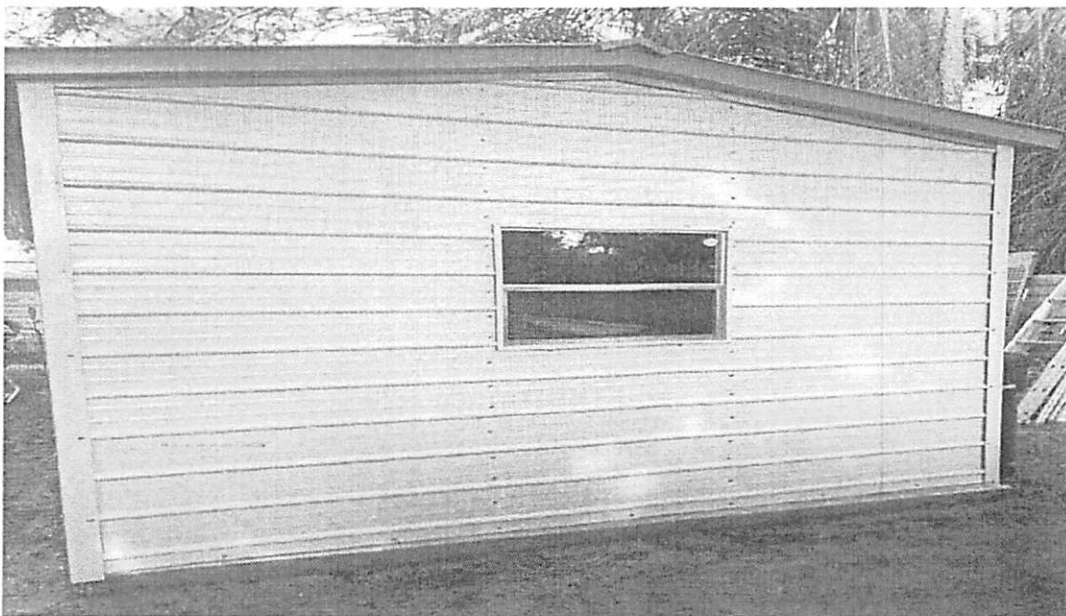

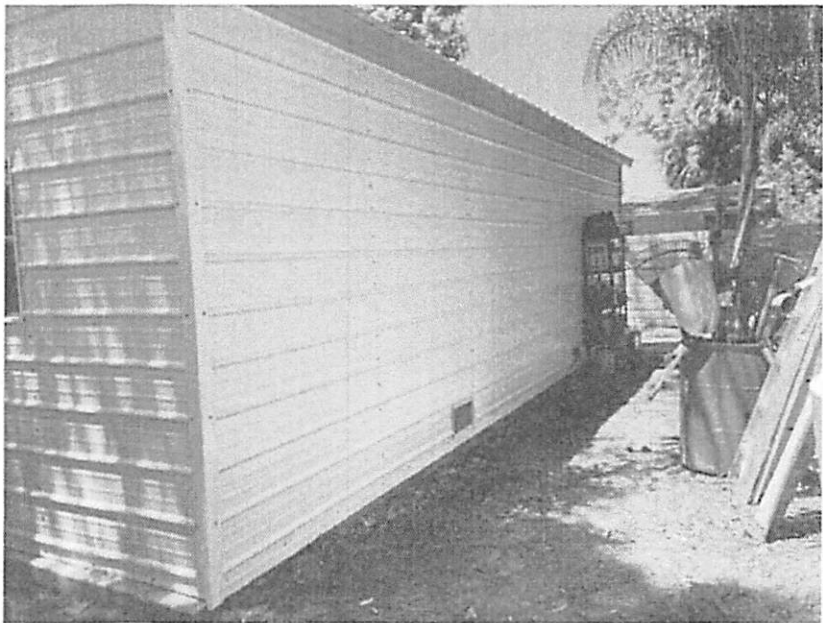

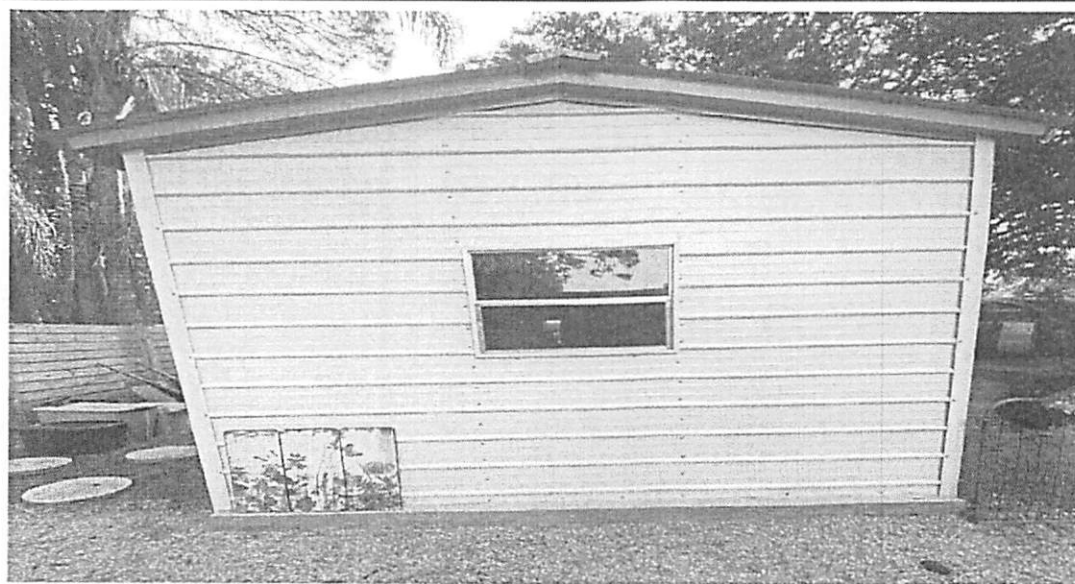
