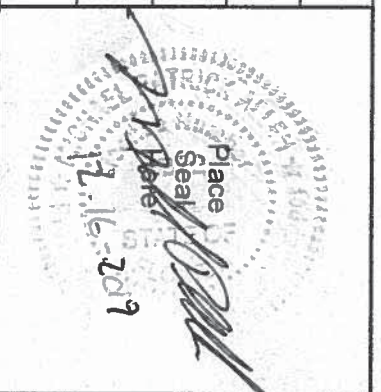

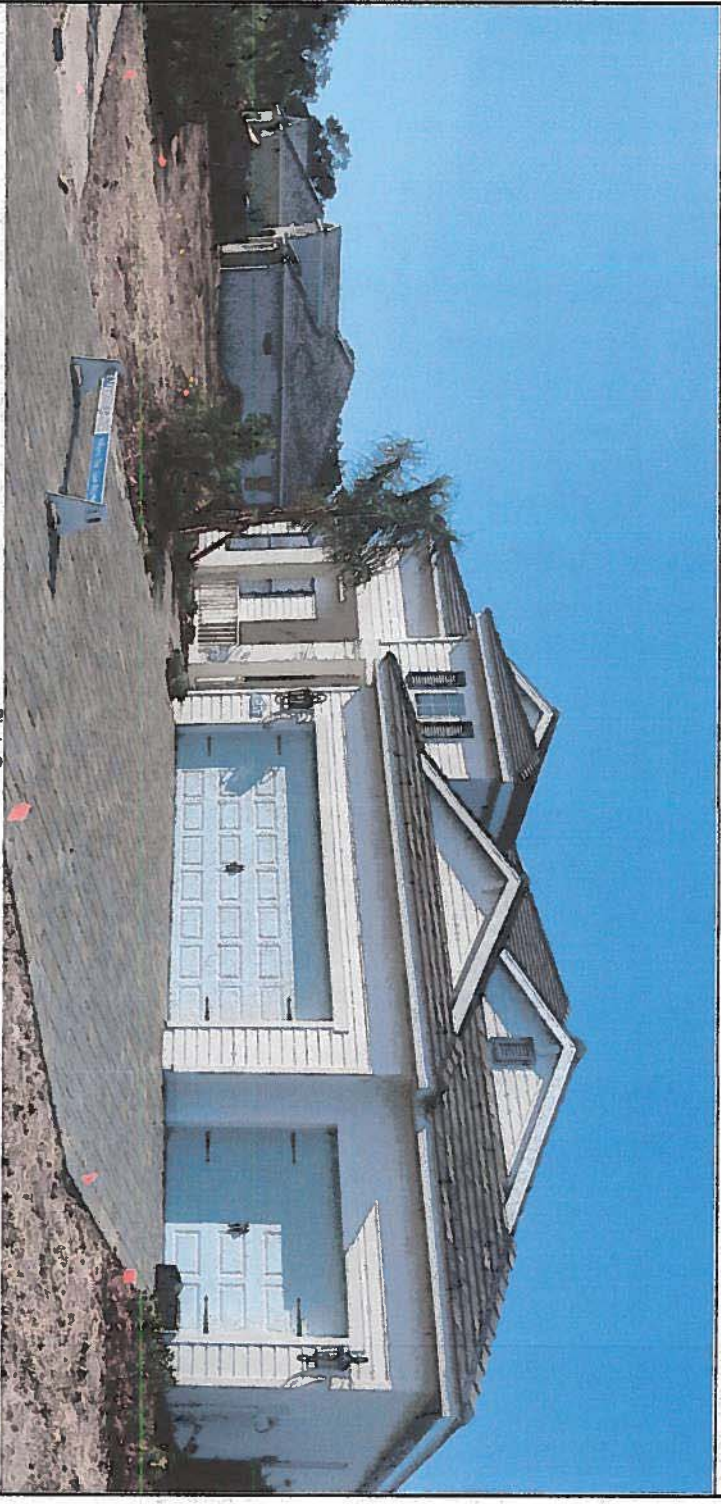

Photo One Caption FRONT 12/16/19

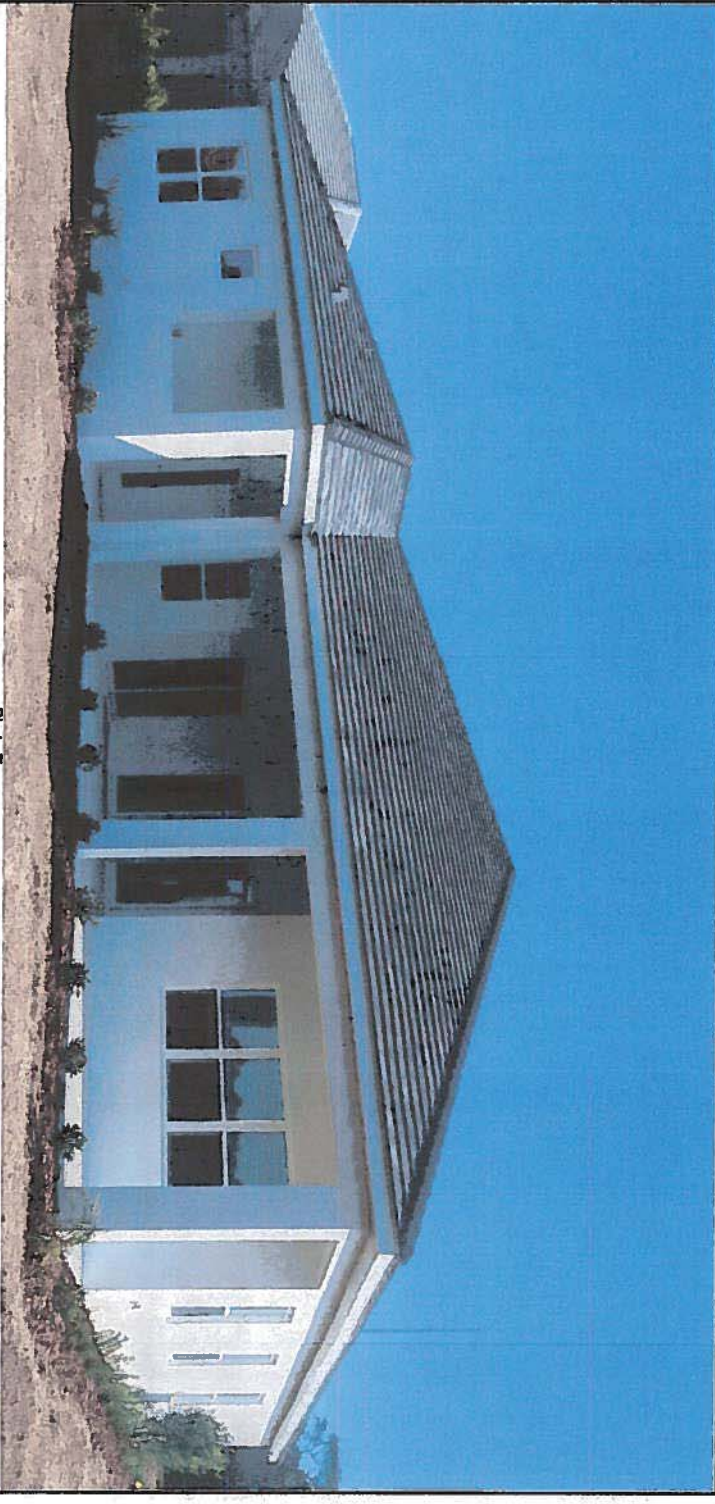
