

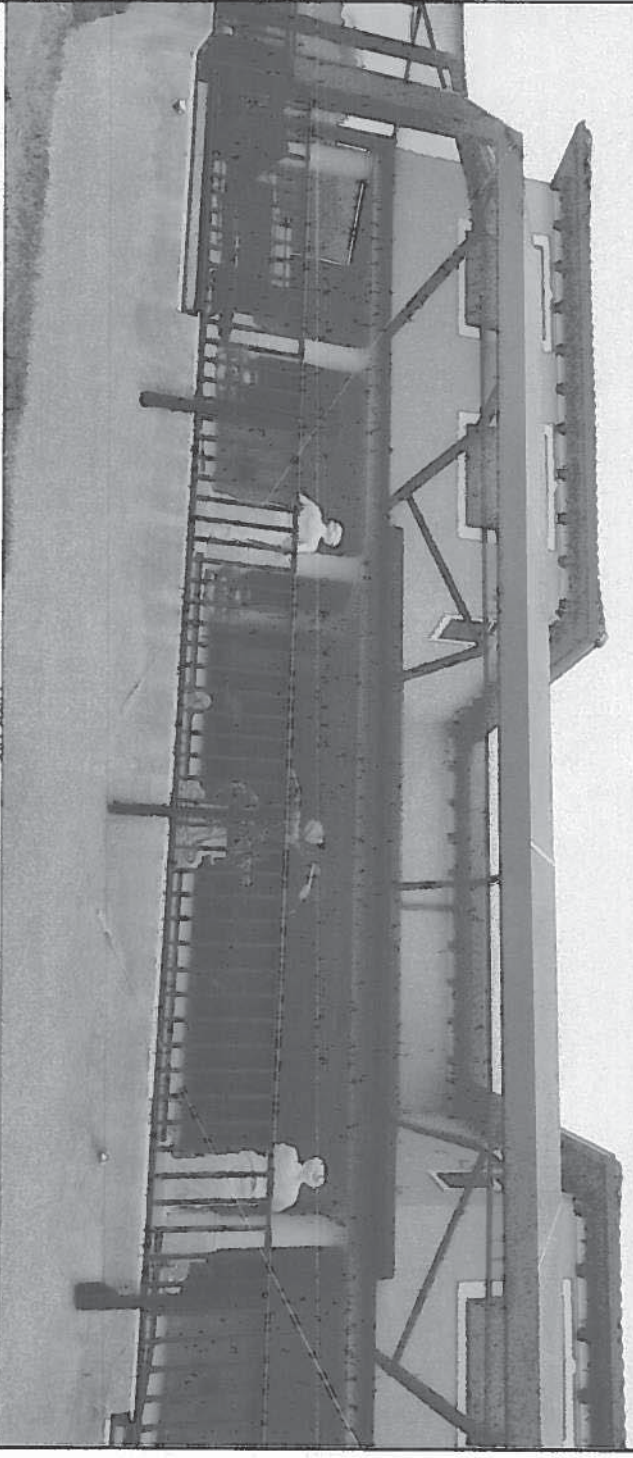


Photo Two Caption Rear View
