





FIGURE 1 - APRIL 17, 2006 - FRONT VIEW

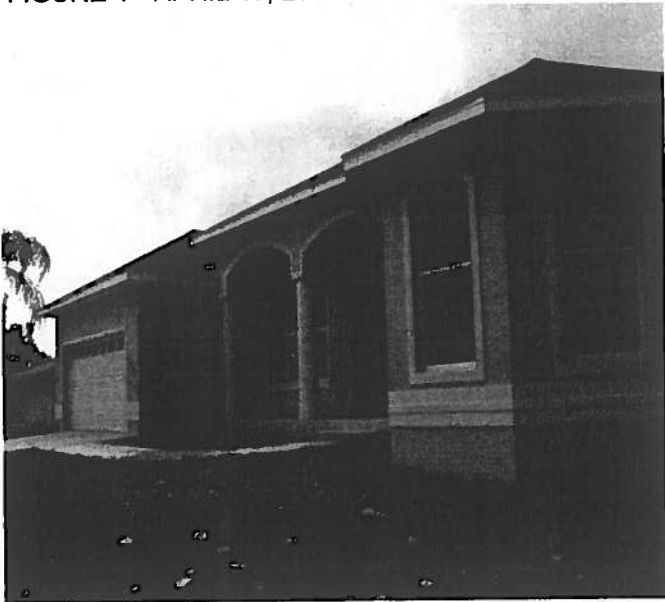


FIGURE 2 - APRIL 17, 2006 - REAR VIEW

THEY ARE WITHIN 8" OF THE FINISHED FLOOR OF THE GARAGE

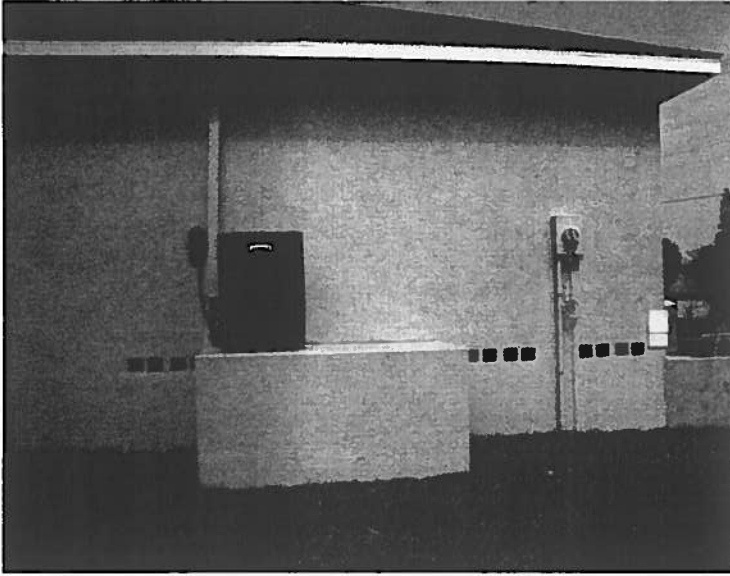


FIGURE 4 - APRIL 17, 2006 – FLOW THRU'S/ RIGHT SIDE VIEW
