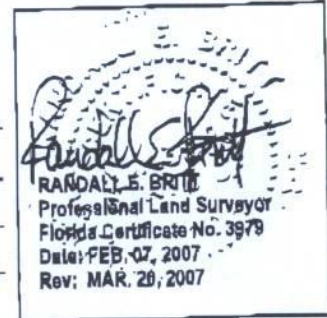

FIGURE 1 - FRONT VIEW (2/7/07)

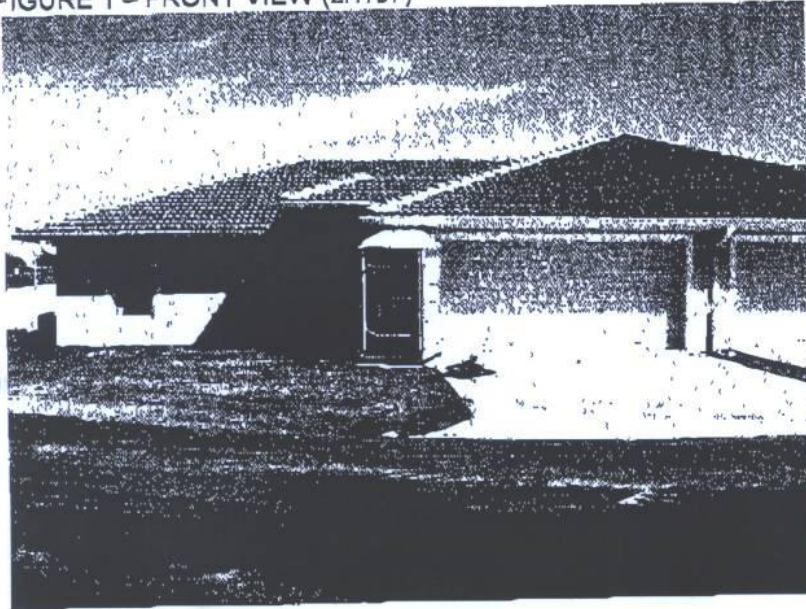


FIGURE 2 - REAR /LEFT SIDE VIEW (2/7/07)
