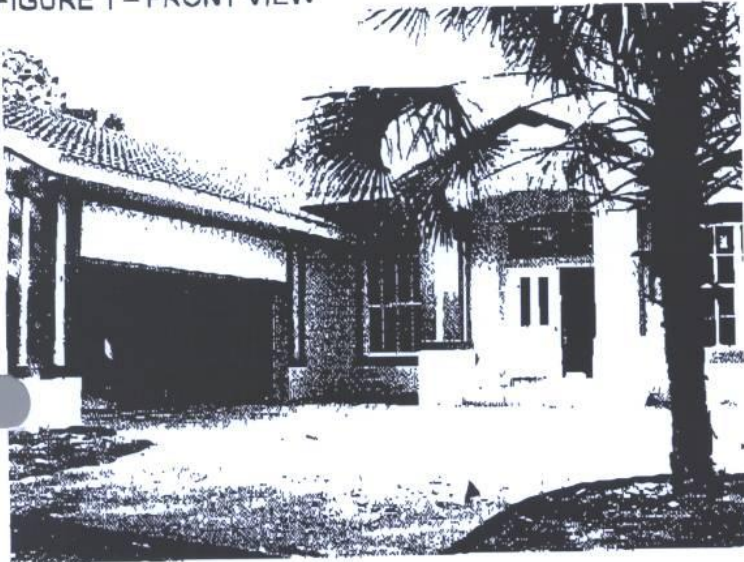


FIGURE 2 - REAR VIEW
