

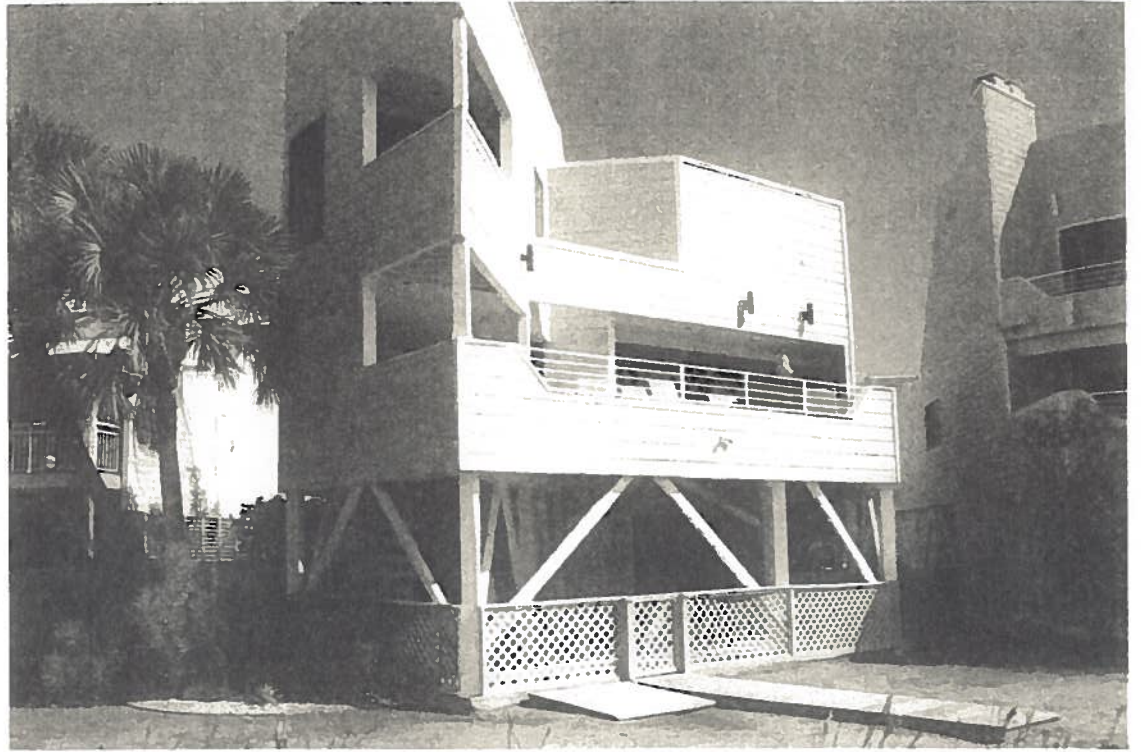

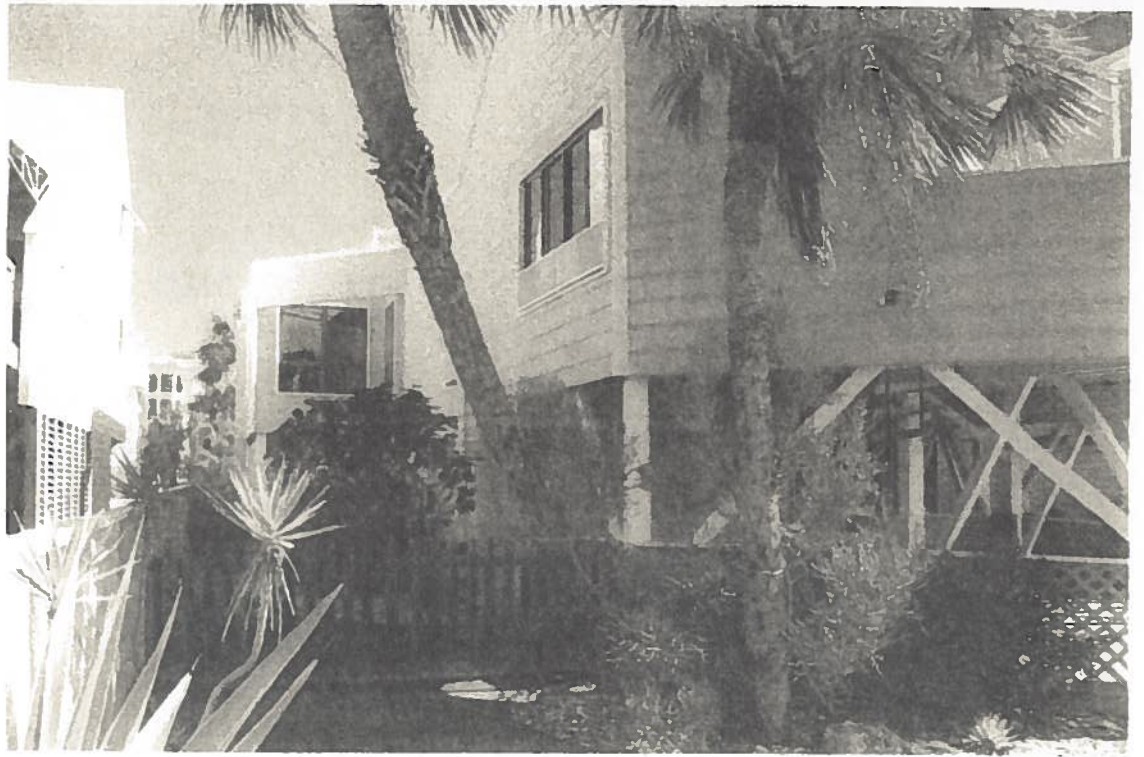
FRONT VIEW



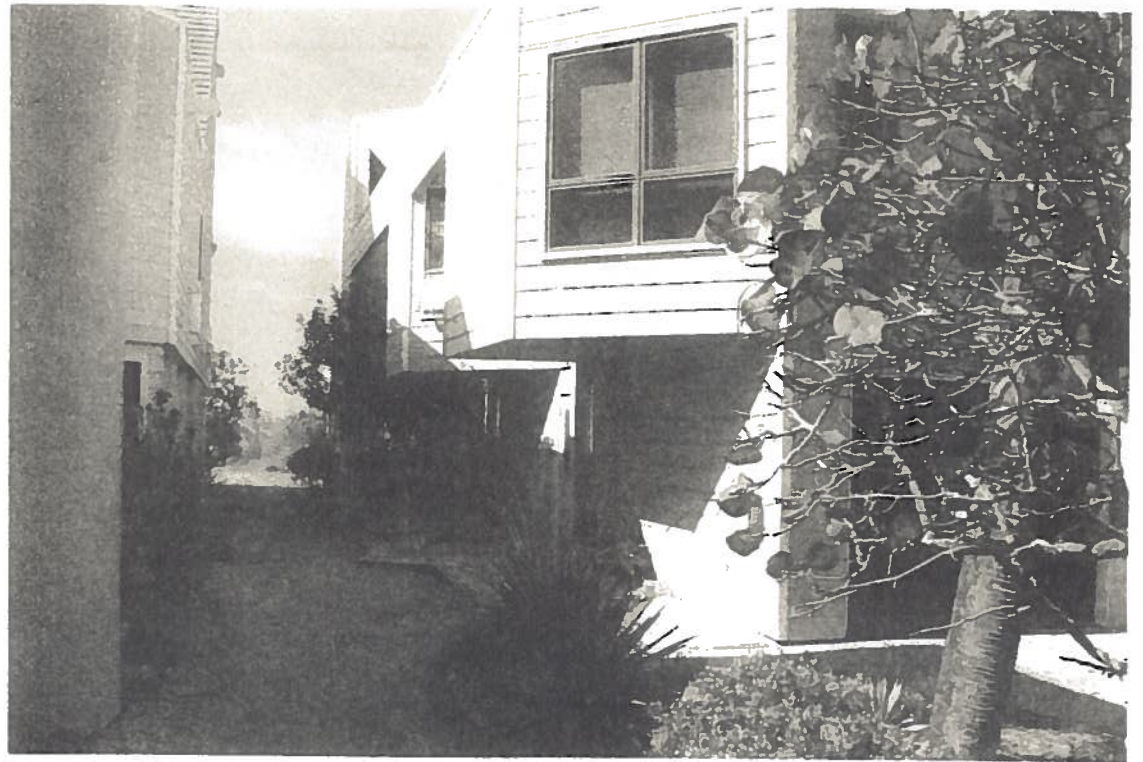
REAR VIEW
