On the effective NFIP Flood Insurance Rate Map (FIRM) the property located at 566 Moon Drive, Venice, Florida (PID 0732-04-0800) is in FEMA FIRM zone A: 125144 panel 0355F, dated 11/04/2016. The Local Flood Study, ICPR model LM\_NAVD88\_20170101.ICP node 182208, dated 1/1/2017 shows the 100yr 24hr flood stage is 8.3 NAVD.

This determination is based on the County's adopted Flood Insurance Rate Maps (FIRM) and the Sarasota County Local Flood Study. This letter does not imply the subject property will or will not be free from flooding or damage. A property not located in a Special Flood Hazard Area, or elevated to or above the BFE or 100-yr stage may be damaged by a flood greater than predicted by the applicable flood study or from a local drainage problem not indicated by applicable study.
