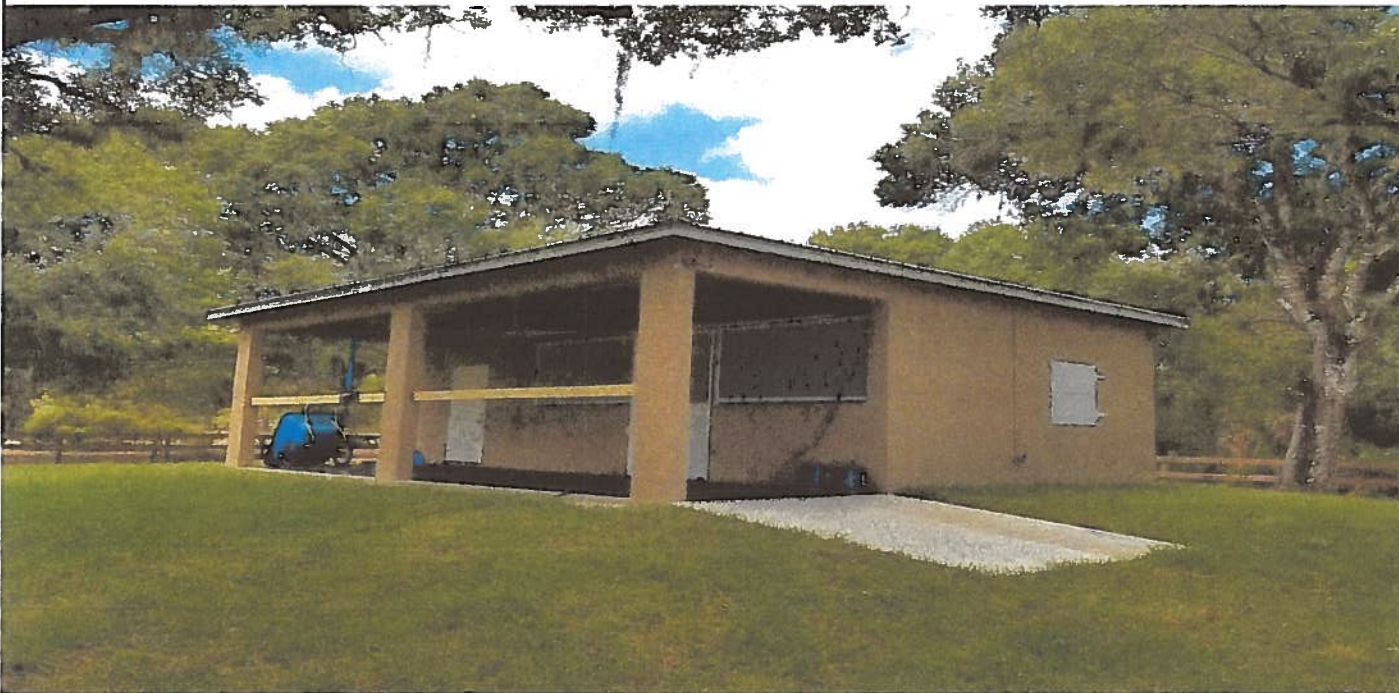


Photo One Caption 5833 Old Ranch Road - BARN
