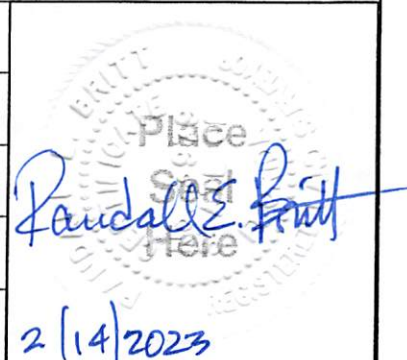

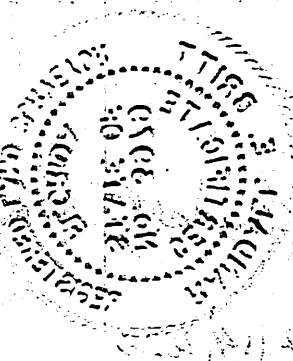

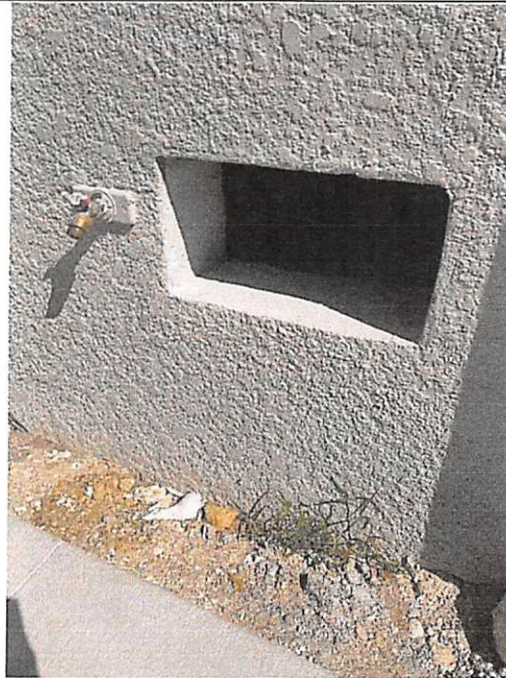

Photo Three Caption Flow through, 02-14-2023, approx area = 1.7ft x 0.7 ft = 1.19 sf each Clear Photo Three

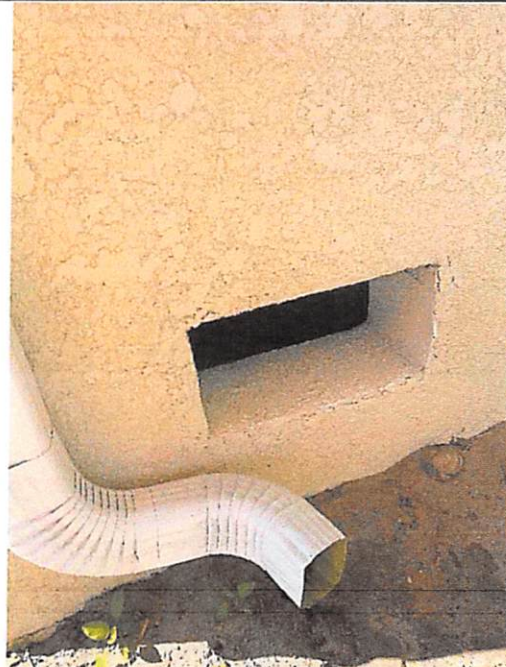
