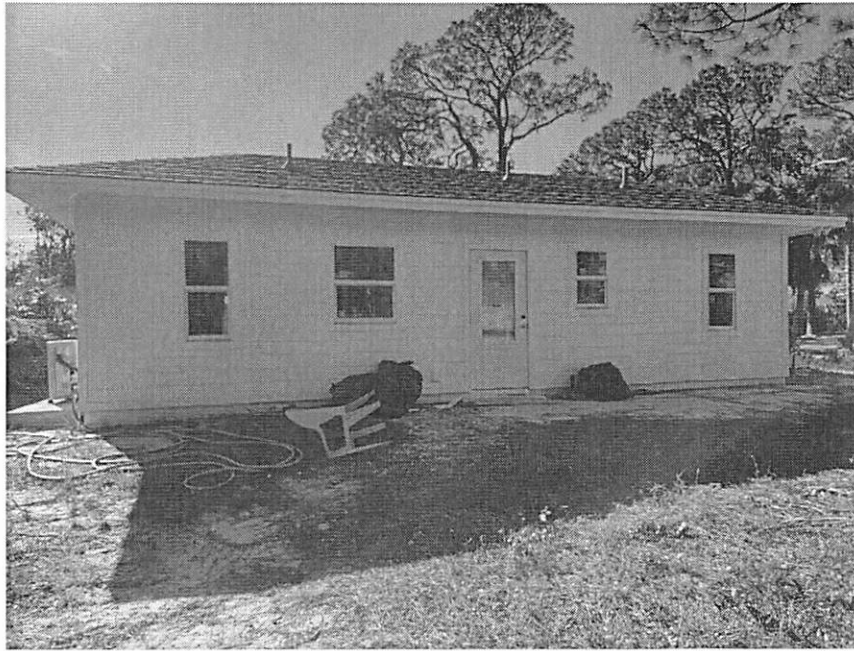

Photo One Caption FRONT VIEW 2/6/2023

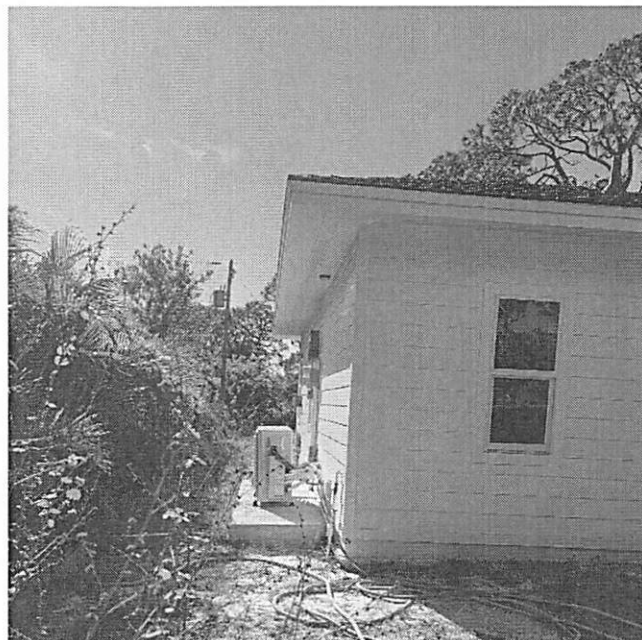

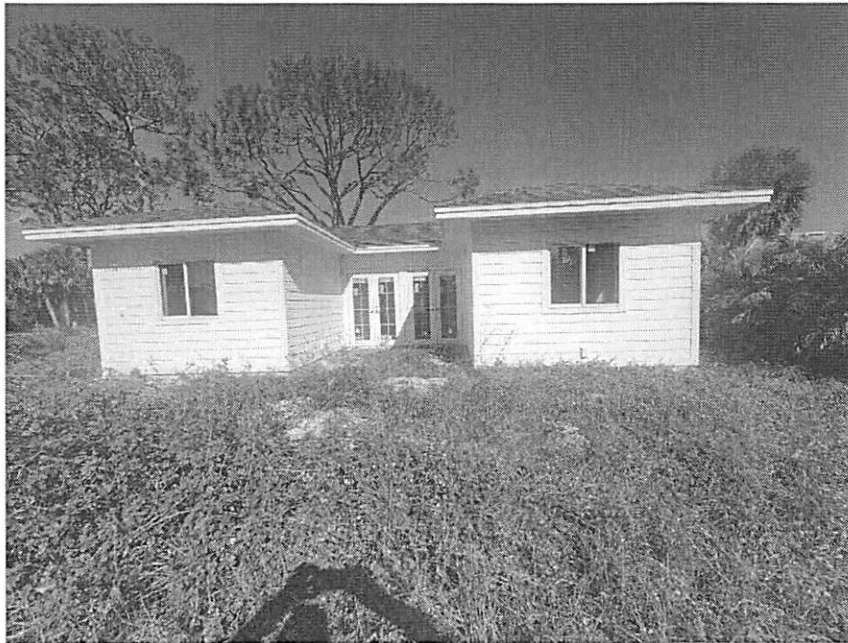

Photo One Caption REAR VIEW 2/6/2023

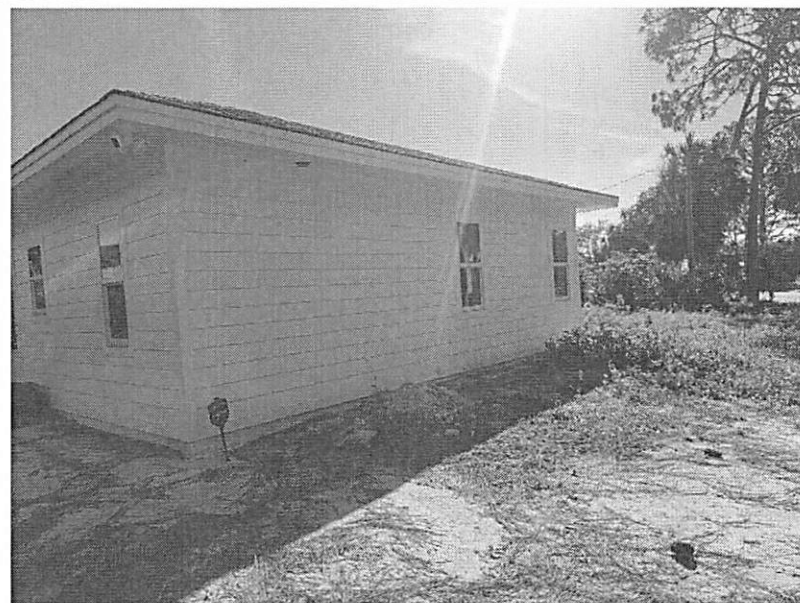
