ORDINANCE NO. 2006- 028

AN ORDINANCE OF THE COUNTY OF SARASOTA, FLORIDA, AMENDING THE OFFICIAL ZONING ATLAS, AS PART OF SARASOTA COUNTY ORDINANCE NO. 2003-052, CODIFIED IN APPENDIX A TO THE SARASOTA COUNTY CODE, RELATING TO ZONING WITHIN THE UNINCORPORATED AREA OF SARASOTA COUNTY; PROVIDING FINDINGS; PROVIDING FOR AMENDMENT OF THE ZONING ATLAS; PROVIDING RESTRICTIONS, STIPULATIONS AND SAFEGUARDS; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF SARASOTA COUNTY, FLORIDA:

Section 1. Findings. The Board of County Commissioners, hereinafter referred to as the "Board," hereby makes the following findings:

- A. The Board has received and considered the report of the Sarasota County Planning Commission concerning Rezoning Petition No. 05-17, requesting rezoning of the property described herein.
- B. The Board has held a public hearing on the proposed rezoning of the property described herein in accordance with the requirements of Sarasota County Ordinance No. 2003-052, codified in Appendix A of the Sarasota County Code (hereinafter "the Zoning Ordinance"), and has considered the information received at said public hearing.
- C. The rezoning herein granted is consistent with the Sarasota County Comprehensive Plan and meets the requirements of the Zoning Ordinance.
- D. Pursuant to the provisions of Article VII of Chapter 94 of the Sarasota County Code, an evaluation has been completed of the impacts that the proposed rezoning of the property described herein will have on the levels of service for parks, drainage, solid waste, roads, mass transit and water and sewer systems. With the exception of the provisions of Section 3 of this Ordinance, adequate levels of service are anticipated to be available.

Section 2. Amendment of the Zoning Ordinance. The Official Zoning Atlas, adopted under Article 4 of the Zoning Ordinance, is hereby amended by changing the zoning district classification for .298 acres ± from District RSF-1 (Residential Single-Family, 2.5 units/acre) to District RSF-2 (Residential Single-Family, 3.5 units/acre) for the following described property located in Sarasota County, Florida:



The legal description of said property in Sarasota County, Florida, being: The east side of Bayshore Road, approximately 150 feet north of Indiana Avenue, being more particularly described as follows: COMMENCE AT A CONCRETE MONUMENT AT THE INTERSECTION OF THE NORTH RIGHT-OF-WAY LINE OF INDIAN ROAD AND THE EAST RIGHT-OF-WAY LINE OF BAY SHORE ROAD (A 20 FOOT PRIVATE ROAD); THENCE N 26°15'00"W, AND ALONG THE EAST RIGHT-OF-WAY LINE OF BAY SHORE ROAD, A DISTANCE OF 146.28 FEET TO THE POINT OF BEGINNING; THENCE CONTINUING N 26°15'00"W 24.68 FEET TO A CONCRETE MONUMENT; THENCE N 32°45'00"W AND ALONG THE EAST RIGHT-OF-WAY LINE OF BAY SHORE ROAD, A DISTANCE OF 75.32 FEET TO A CONCRETE MONUMENT; THENCE N 87°28'00"E, A DISTANCE OF 150.00 FEET TO A CONCRETE MONUMENT; THENCE S 28°08'14"E, A DISTANCE OF 100 FEET; THENCE S 88°27'04"W, A DISTANCE OF 145.40 FEET TO THE POINT OF BEGINNING, AND LYING AND BEING IN THE SE 1/4 OF SECTION 23, TOWNSHIP 38 SOUTH, RANGE 18 EAST, SARASOTA COUNTY, FLORIDA.

Section 3. Restrictions, Stipulations and Safeguards. As used in the stipulations hereinafter set forth, the term "Owner" shall refer to the owner or owners of the property described in Section 2 and their successors and assigns. Upon recording in the public records of Sarasota County, these stipulations shall be covenants running with the land. The use of the property described in Section 2 of this Ordinance, in addition to the applicable restrictions imposed by the Zoning Ordinance, is hereby further limited by and subject to the following restrictions, stipulations and safeguards:

Section 4. Effective Date. This Ordinance shall take effect immediately upon receipt of official acknowledgment from the Office of the Secretary of State of Florida that this Ordinance has been filed with said office.
