

## **ORDINANCE NO. 2008 - 099**

AN ORDINANCE OF THE COUNTY OF SARASOTA, FLORIDA, AMENDING THE OFFICIAL ZONING ATLAS, AS PART OF SARASOTA COUNTY ORDINANCE NO. 2003-052, CODIFICIO IN APPENDIX A TO THE SARASOTA COUNTY CODE, COUNTY RELATING TO ZONING WITHIN THE UNINCORPORATED AREA OF SARASOTA COUNTY; PROVIDING FINDINGS; PROVIDING FOR AMENDMENT OF THE ZONING ATLAS; PROVIDING RESTRICTIONS, STIPULATIONS AND SAFEGUARDS; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF SARASOTA COUNTY, FLORIDA:

Section 1. Findings. The Board of County Commissioners, hereinafter referred to as the "Board," hereby makes the following findings:

- A. The Board has received and considered the report of the Sarasota County Planning Commission concerning Rezoning Petition No. 08-10, requesting rezoning of the property described herein.
- B. The Board has held a public hearing on the proposed rezoning of the property described herein in accordance with the requirements of Sarasota County Ordinance No. 2003-052, codified in Appendix A of the Sarasota County Code (hereinafter "the Zoning Ordinance"), and has considered the information received at said public hearing.
- C. The rezoning herein granted is consistent with the Sarasota County Comprehensive Plan and meets the requirements of the Zoning Ordinance.
- D. Pursuant to the provisions of Article VII of Chapter 94 of the Sarasota County Code, an evaluation has been completed of the impacts that the proposed rezoning of the property described herein will have on the levels of service for parks, drainage, solid waste, roads, mass transit and water and sewer systems. With the exception of the provisions of Section 3 of this Ordinance, adequate levels of service are anticipated to be available.

Section 2. Amendment of the Zoning Ordinance. The Official Zoning Atlas, adopted under Article 4 of the Zoning Ordinance, is hereby amended by changing the zoning district classification from RSF-2 (Residential, Single-Family, 3.5 units/ acre) to RSF-4 (Residential, Single-Family, 5.5 units/ acre) zone district for the following described property located in Sarasota County, Florida:

The legal description of said property in Sarasota County, Florida, being: south of Colonia Lane and east of Ravenna Street and being more particularly described as follows:

From the NE corner of the SE ¼ of the NE ¼ of Section 6, Township 39 South, Range 19 East, Run westerly along the north line of the SE ¼ of the NE ¼ a distance of 1805.40 feet to the point of beginning;

thence continue westerly along said line a distance of 60 feet; thence south 0'05'08" west a distance of 207 feet more or less to the north line of lands described in O.R. 1359, page 1945; thence east along the north line of lands described in O.R. 1359, page 1945, 60 feet; thence north 0'19'00" west along a west line, and the extension of said west line, of lands described in O.R. 1359, page 1945, 205 feet, more or less, to the point of beginning. Subject to the Right of Way of Colonia Lane.

Section 3. Restrictions, Stipulations and Safeguards. As used in the stipulations hereinafter set forth, the term "Owner" shall refer to the owner or owners of the property described in Section 2 and their successors and assigns. Upon recording in the public records of Sarasota County, these stipulations shall be covenants running with the land. The use of the property described in Section 2 of this Ordinance, in addition to the applicable restrictions imposed by the Zoning Ordinance, is hereby further limited by and subject to the following restrictions, stipulations and safeguards:

- 1. Development shall conform to the Nokomis Center Revitalization Plan.
- 2. Development shall be limited to one principal dwelling unit and customary accessory structures on the parcel.

Section 4. Effective Date. This Ordinance shall take effect upon filing with the Department of State.
