AN ORDINANCE OF THE COUNTY OF SARASOTA, FLORIDA, AMENDING THE OFFICIAL ZONING ATLAS. AS PART OF SARASOTA COUNTY ORDINANCE NO. 2003-052, CODIFIED IN APPENDIX A TO THE SARASOTA COUNTY CODE, RELATING TO ZONING WITHIN THE UNINCORPORATED AREA OF SARASOTA COUNTY: PROVIDING FINDINGS; PROVIDING FOR AMENDMENT OF THE ZONING ATLAS; PROVIDING RESTRICTIONS, STIPULATIONS AND SAFEGUARDS; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF SERE

Section 1. Findings. The Board of County Commissioners, hereinafter referred in Board." hereby makes the following findings:

- The Board has received and considered the report of the Sarasota County Planning Commission concerning Rezoning Petition No. 13-10, requesting rezoning of the property described herein.
- 2. The Board has held a public hearing on the proposed rezoning of the property described herein in accordance with the requirements of Sarasota County Ordinance No. 2003-052, codified in Appendix A of the Sarasota County Code (hereinafter "the Zoning Ordinance"), and has considered the information received at said public hearing.
- 3. The rezoning herein granted is consistent with the Sarasota County Comprehensive Plan and meets the requirements of the Zoning Ordinance.
- 4. Pursuant to the provisions of Article VII of Chapter 94 of the Sarasota County Code, an evaluation has been completed of the impacts that the proposed rezoning of the property described herein will have on the levels of service for parks, drainage, solid waste, roads, mass transit and water and sewer systems. With the exception of the provisions of Section 3 of this Ordinance, adequate levels of service are anticipated to be available.

Section 2. Amendment of the Zoning Ordinance. The Official Zoning Atlas, adopted under Article 4 of the Zoning Ordinance, is hereby amended by changing the zoning district classification from OUE-1 (Open Use, Estate, 1 unit/5 acres) to ILW (Industrial, Light Manufacturing, and Warehousing) zone district for the following described property located in Sarasota County, Florida:

West of East Road, south of Moyer Avenue and being more particularly described as follows:


The South one-half of Tract 14 of the Fifth Unit of Palmer Farms, a subdivision in Sections 20, 19, and 32, Township 36 South, Range 19 East, as per Plat thereof recorded in Plat Book 3, Page 15, of the Public Records of Sarasota County, Florida: Less the Southerly 402.33 feet thereof.

Section 3. Restrictions. Stipulations and Safeguards. As used in the stipulations hereinafter set forth, the term "Owner" shall refer to the owner or owners of the property described in Section 2 and their successors and assigns. Upon recording in the public records of Sarasota County, these stipulations shall be covenants running with the land. The use of the property described in Section 2 of this Ordinance, in addition to the applicable restrictions imposed by the Zoning Ordinance, is hereby further limited by and subject to the following restrictions, stipulations and safeguards:

- All development shall be consistent with the "Perpetual Covenant and Restrictions Restricting Allowable Uses on Parcels of Real Property" as adopted by Resolution No. 2002-140.
- The Master Surface Water Management Plan shall be consistent with the Phillippi Creek Basin Master Plan.
- 3. There shall be no direct vehicular access to East Road.

Section 5. Effective Date. This Ordinance shall take effect upon filing with the Department of State.
