N.19'13'12"E. 687.44 feet to a point on the North line of said Lot 14; thence N.88°04'48"E., 308.26 feet to the Point of Beginning. TOGETHER with an EASEMENT for ingress and egress described as follows: Begin at the most Southerly corner of Lot 14, The Ranches at Bern Creek, recorded in Plat Book 30, Pages 24, 24A through 24D, Public Records of Sarasota County. Florida, said corner being in centerline of Moccasin Hollow Road, a 60' private road easement; thence N.68°06'55"E. along South line of said Lot 14, a distance of 30.0 feet to the Right of Way line of Moccasin Hollow Road; thence N.19°13'12"E., 79.63 feet; thence S.68°06"55W., 92.07 feet to a point on the lot line, and centerline of said Moccasin Hollow Road; thence Southeasterly along said lot line and centerline, along a curve to the left having a radius of 190.0 feet, through a central angle of 18°24'31" an arc distance of 61.05 feet (chord= S.31°05'20"E., 60.78 feet) to the Point of Beginning. SUBJECT to platted private road easement for Moccasin Hollow Road.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Sarasota County, Florida, in public meeting assembled:

Section 1. Based on the evidence and testimony presented, as contained in the record of this application, the Rezone Petition is hereby **DENIED**.

Section 2. This Resolution shall take effect immediately upon its adoption. The Clerk shall transmit a certified copy of this Resolution to the Petitioner by certified mail, return receipt requested.
