ORDINANCE NO. 2010 - 014

AN ORDINANCE OF THE COUNTY OF SARASOTA, FLORIDA, AMENDING THE OFFICIAL ZONING ATLAS, AS PART OF SARASOTA COUNTY ORDINANCE NO. 2003-052, CODIFIED IN APPENDIX A TO THE SARASOTA COUNTY CODE; ING RELATING TO ZONING WITHIN THE UNINCORPORATED COUNTY AREA OF SARASOTA COUNTY; PROVIDING FINDINGS; PROVIDING FOR AMENDMENT OF THE ZONING ATLAS; PROVIDING RESTRICTIONS, STIPULATIONS AND SAFEGUARDS; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF SARASOTA COUNTY, FLORIDA:

Section 1. Findings. The Board of County Commissioners, hereinafter referred to as the "Board," hereby makes the following findings:

- A. The Board has received and considered the report of the Sarasota County Planning Commission concerning Rezoning Petition No. 09-12, requesting rezoning of the property described herein.
- B. The Board has held a public hearing on the proposed rezoning of the property described herein in accordance with the requirements of Sarasota County Ordinance No. 2003-052, codified in Appendix A of the Sarasota County Code (hereinafter "the Zoning Ordinance"), and has considered the information received at said public hearing.
- C. The rezoning herein granted is consistent with the Sarasota County Comprehensive Plan and meets the requirements of the Zoning Ordinance.
- D. Pursuant to the provisions of Article VII of Chapter 94 of the Sarasota County Code, an evaluation has been completed of the impacts that the proposed rezoning of the property described herein will have on the levels of service for parks, drainage, solid waste, roads, mass transit and water and sewer systems. With the exception of the provisions of Section 3 of this Ordinance, adequate levels of service are anticipated to be available.
- Section 2. Amendment of the Zoning Ordinance. The Official Zoning Atlas, adopted under Article 4 of the Zoning Ordinance, is hereby amended by changing the zoning district classification from OUE-1 (Open Use Estate, 1 unit/5 acres) to RSF-1 (Residential Single Family, 2.5 units/acre) zone district for the following described property located in Sarasota County, Florida:

Approximately 600 feet north of Venice Avenue and west of Greencove Road and being more particularly described as follows:

Tract 113, VENICE FARMS, according to the plat thereof recorded in Plat Book 2, Page 179, of the Public Records of Sarasota County, Florida.

Section 3. Restrictions, Stipulations and Safeguards. As used in the stipulations hereinafter set forth, the term "Owner" shall refer to the owner or owners of the property described in Section 2 and their successors and assigns. Upon recording in the public records of Sarasota County, these stipulations shall be covenants running with the land. The use of the property described in Section 2 of this Ordinance, in addition to the applicable restrictions imposed by the Zoning Ordinance, is hereby further limited by and subject to the following restrictions, stipulations and safeguards:

- 1. Development of the subject parcel shall be consistent with all applicable conditions of the East Venice Avenue Overlay.
- 2. Gross density shall not exceed 1.90 dwellings units per acre, with a maximum of eight lots.
- 3. All stormwater treatment shall be open and above ground.
- 4. The Master Surface Water Management Plan shall be consistent with the applicable Curry Creek Basin Master Plan and the Myakka River Basin Master Plan.
- 5. The developer/owner shall provide interconnection of internal access roadways and pedestrian facilities to adjacent parcels to the north and south of the subject parcel as shown on the Development Concept Plan.
- 6. The Owner shall provide a Water Quality Plan that demonstrates how the development will maintain compliance with applicable drinking water quality standards within the development without the need for flushing of the water lines. This Plan shall be submitted to the Utilities Department and approved by Sarasota County prior to Construction Plan approval.
- 7. Prior to receiving Construction Authorization, Developer shall submit a Lift Station Plan and hydraulic model of the wastewater collection system. Developer shall be responsible for any off-site improvements necessary to accommodate the additional flows within the wastewater system.

Section 4. Effective Date. This Ordinance shall take effect upon filing with the Department of State.
